Our website uses cookies to distinguish you from other users of our website. This helps us to provide you with a good experience when you browse our website and also allows us to improve our site. A cookie is a small file of letters and numbers that we store on your browser or the hard drive of your computer if you agree. Cookies contain information that is transferred to your computer's hard drive.

We use the following cookies:

- **Strictly necessary cookies.** These are cookies that are required for the operation of our website. They include, for example, cookies that enable you to log into secure areas of our website, use a shopping cart or make use of e-billing services.
- Analytical or performance cookies. These allow us to recognise and count the number of visitors and to see how visitors move around our website when they are using it. This helps us to improve the way our website works, for example, by ensuring that users are finding what they are looking for easily.
- **Functionality cookies.** These are used to recognise you when you return to our website. This enables us to personalise our content for you, greet you by name and remember your preferences (for example, your choice of language or region).
- Targeting cookies. These cookies record your visit to our website, the pages you have visited and the links you have followed. We will use this information to make our website and the advertising displayed on it more relevant to your interests.

Analytical or performance cookies

When you visit our website, our web server temporarily evaluates this for statistical purposes in order to improve the quality of our website. This data consists of the following data categories:

- The name and the address of the requested content,
- The date and time of the query, of the transferred data volume
- The access status (content transferred, contend not found)
- The description of the used web browser and operating system,
- The referral link, which indicates from which page you reached us,
- The IP address of the requesting computer, which is shortened in such a way that a personal reference can no longer be established.

The above-mentioned information will only be evaluated anonymously.

Storage of IP Addresses for Security Purposes

We store the complete IP address transmitted by your web browser for a period of **sixty days** in the interest of detecting, limiting, and eliminating attacks on our web pages. After this period, we delete or anonymize the IP address.

Necessary Cookies

On our Website, we use cookies which are necessary in order for the site to function. A distinction is made between session cookies, which are deleted as soon as you close your browser, and permanent cookies, which are stored beyond the individual session.

We do not use the necessary cookies for analysis, tracking or advertising purposes. In some cases, these cookies only contain information on certain settings and cannot be linked to a person. They may also be necessary to enable user guidance, security, and implementation of the site.

You can set your browser to inform you about the placement of cookies. This is in order to make the use of cookies transparent for you. You can also delete cookies to prevent setting of new cookies at any time by using the appropriate browser settings.

Please note that if you delete certain cookies, our web pages may not be displayed correctly, and some functions may no longer be available.

Google Analytics

We use the web analysis tool "Google Analytics" to design our websites according to your needs. Space Google Analytics creates user profiles based on pseudonyms. For this purpose, permanent cookies are stored on your end device and accessed out by us. In this way we are able to recognise and measure returning visitors.

The Google Analytics tool is provided by Google Ireland limited and Google LLC. USA who support us and processes according to art. 28 GDPR. The data processing can therefore also take place outside the EU all EEA. With regard to Google LLC USA no adequate level of data protection can be assumed due to the processing in the USA.

There is a risk that authorities may access the Personal Data for security and surveillance purposes without you being informed or having the right to appeal.

Third party tracking technologies for advertising

How does tracking work?
